Summary

- 1. This document describes how the Higher Education Students Early Statistics (HESES) recreation data can be rebuilt from the HESES22 comparison individualised file as generated by the 2022-23 ILR data checking tool.
- 2. The HESES22 comparison is formed of two files. These are:
 - a. HESES22 comparison workbook 'HES22_DCT_XXXXXXXX.xlsx'.
 - b. HESES22 comparison individualised file 'HES22_DCT_XXXXXXX_IND.csv'.

where XXXXXXXX is the UK Provider Reference Number (UKPRN) for the provider.

3. Each section of this document details how to rebuild specific populations of students that appear on the tables in the HESES22 comparison workbook. These tables are listed below.

5. For the population that appears in this table, the first filters to apply to the individualised file are:

HESEXCL = 0 HESREG = 1

6. To further filter these years of instance, the following fields can be used:

LEARNAIMREF HESMODE HESRESSTAT.

7. For example, to filter to full-time years of instance that are fundable and UK-domiciled for LEARNAIMREF = 00123456, then the filters to apply to the individualised file are as follows:

9. Additional filters can be applied to specify years of instance in a particular cell, such as filtering by price group, length of year of instance, level of study, and residential and fundability status.

10. For example, to filter to years of instance on this table that are fundable, in Column 1, and on a standard length year of instance of another undergraduate course, the filters to apply to the individualised file are the following:

HESEXCL = 0 HESMODE = FTS LENGTH = S HESLEVEL = UG_OTH HESTYPE = HOMEF HESREG = 1.

To find the estimated number of completed years of instance (i.e. recorded in Column 4 of the HESES22 recreation), sum the values of HESCOL4. To find the estimated number of years of instance that were not completed (i.e. recorded in Column 3 of the HESES22 recreation), sum the values of HESCOL3. To find the estimated FTE, sum the values of HESCOL4A. The Column 3 and Column 4 totals may not be whole numbers, but the sum of these totals will equal the number of years of instance found by applying the filters above.

11. For example, to filter to years of instance on this table that are fundable, in Column 1, in price group C1.1, and on a standard length year of instance of a Level 4 or 5 undergraduate course, the filters to apply to the individualised file are:

HESEXCL = 0 HESMODE = FTS PRGC11 \neq 0 LENGTH = S HESLEVEL = UG_45 HESTYPE = HOMEF HESREG = 1.

To find the total years of instance meeting these criteria, sum the values of PRGC11. Of these years, the number estimated to have not been completed (i.e. recorded in Column 3 of the HESES22 recreation) is the sum of the values of HESCOL3_C11, and the number estimated to have been completed (i.e. recorded in Column 4 of the HESES22 recreation) is the sum of the values of HESCOL4_C11. The Column 3 and Column 4 totals may not be whole numbers, but the sum of these totals will equal the sum of the values of PRGC11. In summary, (sum of HESCOL3_Y) + (sum of HESCOL4_Y) = (sum of PRGY), where Y is the price group. The FTE of the years of instance found by applying the filters above is the sum of the values of FTEC11 divided by 100.

Table 2: Sandwich year out counts of years of instance

12. For the population that appears in this table, the first filters to apply to the individualised file are:

HESEXCL = 0 HESMODE = SWOUT.

- 13. Further filters that can be applied are the same as those in Table 1: Full-time counts of years of instance.
- 14. To find the total years of instance in this population, sum the values of PRGC2. Of these years, the number estimated to have not been completed (i.e. recorded in Column 3 of the HESES22 recreation) is the sum of the values of HESCOL3_C2, and the number estimated to have been completed (i.e. recorded in Column 4 of the HESES22 recreation) is the sum of the values of HESCOL4_C2. The Column 3 and Column 4 totals may not be whole numbers, but the sum of these totals will equal the sum of the values of PRGC2. The FTE of these years of instance is the sum of the values of FTEC2 divided by 100.

15. For the population that appears in this table, the first filters to apply to the individualised file are:

HESEXCL = 0 HESMODE = PT.

- 16. Further filters that can be applied are the same as those in Table 1: Full-time counts of years of instance.
- 17. For example, to filter to years of instance on this table that are fundable, in Column 2 and on a standard length year of instance of another undergraduate course, the filters to apply to the individualised file are:

HESEXCL = 0 HESMODE = PT LENGTH = S HESLEVEL = UG_OTH HESTYPE = HOMEF HESREG = 2.

To find the estimated number of completed years of instance (i.e. recorded in Column 4 of the HESES22 recreation), sum the values of HESCOL4. To find the estimated number of years of instance that were not completed (i.e. recorded in Column 3 of the HESES22 recreation), sum the values of HESCOL3. To find the estimated FTE (i.e. recorded in Column 4a of the HESES22 recreation), sum the values of HESCOL4A. The Column 3 and Column 4 totals may not be whole numbers, but the sum of these totals will equal the number of years of instance found by applying the filters above.

18. For example, to filter to years of instance on this table that are fundable, in Column 1, in price group D, and on a standard length year of instance of a Level 4 or 5 undergraduate course, the filters to apply to the individualised file are:

HESEXCL = 0 HESMODE = PT PRGD ≠ 0 LENGTH = S HESLEVEL = UG_45 HESTYPE = HOMEF HESREG = 1.

19. To find the total years of instance meeting these criteria, sum the values of PRGD. Of these years, the number estimated to have not been completed (i.e. recorded in Column 3 of the HESES22 recreation) is the sum of the values of HESCOL3_D, and the number estimated to have been completed (i.e. recorded in Column 4 of the HESES22 recreation) is the sum of the values of HESCOL4_D. The Column 3 and Column 4 totals may not be whole numbers, but the sum of these totals will equal the sum of the values of PRGD. In summary, (sum of HESCOL3_Y) + (sum of HESCOL4_Y) = (sum of PRGY), where Y is the price group. The FTE of the years of instance found by applying the filters above (which is recorded in Column 4 a of the HESES22 recreation) is the sum of the values of FTED divided by 100.

Table 4: Home fee undergraduate years abroad

- 20. For the population that appears in this table, the first filter to apply to the individualised file is HESYAPOP = 1.
- 21. For students on an outgoing Erasmus+ or Turing year abroad, the filter to apply to the individualised file is HESYATYPE = ERASMUS.
- 22. For students taking an outgoing year abroad outside the Erasmus+ or Turing programme the filter to apply to the individualised file is HESYATYPE = OTHER.
- 23. To identify whether a student is in Column 1 or Column 2 of the table filter to HESREG = 1 or HESREG = 2 respectively.
 - a. To identify students in Column 1(a) and Column 2(a) the filter to apply to the individualised file is HESMODE = FTS.
 - b. To identify students in Column 1(b) and Column 2(b) the filter to apply to the individualised file is HESMODE = SWOUT.
- 24. A further filter can be applied to HESTYPE to filter to students who are either fundable (HESTYPE = HOMEF) or non-fundable (HESTYPE = HOMENF).
- 25. To find the total headcount of students sum the variable HESYAPOP.

Table 5: Further student analysis for planning purposes

- 26. For the population that appears in this table, the first filter to apply to the individualised file is HESEXCL = 0.
- 27. To further filter these years of instance, the following fields can be used:
 - HESLEVEL

HESREG

HESTYPE

HESRESSTAT

HESMODE.

28. For example, to filter to full-time years of instance that are in Column 1, on a Level 4 or 5 undergraduate course, are fundable and UK-domiciled, then the filters to apply to the individualised file are as follows:

HESEXCL = 0 HESREG = 1 HESLEVEL = UG_45 HESMODE = FTS HESRESSTAT = HOMEF_UK. 29. To find the equivalent population of new entrants (i.e., students in Section B of this table), apply the above filters as well as HESNEWENTRANT = 1. To find the total headcount of this population sum the HESNEWENTRANT variable.

Table 6a: Full-time counts of years of instance for home fee students on pre-registration health courses

30. For the population that appears in this table, the first filters to apply to the individualised file are:

HESHEALTHPOP = 1 HESMODE = FTS.

- 31. To identify OfS-fundable years of instance in Column 1(a) and Column 2(a), the filter to apply to the individualised file is HESTYPE = HOMEF.
- 32. To identify non-fundable years of instance in Column 1(b) and Column 2(b), the filter to apply to the individualised file is HESTYPE = HOMENF.
- 33. To identify starters in 2022-23, the filter to apply to the individualised file is HESHEALTHYEAR = 2022-23.
- 34. Use HESHEALTHPROF to identify years of instance for a particular profession.
- 35. Further filters can be applied to identify those with a particular length of year of instance or level of study.
- 36. For example, to identify OfS-fundable years of instance for full-time, undergraduate level, standard length podiatry courses, the filters to apply to the individualised file are:

HESHEALTHPOP = 1 HESMODE = FTS HESTYPE = HOMEF HESHEALTHPROF = PODCHI LENGTH = S HESLEVEL = UG 45, UG OTH.

37. To find the estimated number of completed years of instance (i.e. recorded in Column 4 of Table 6a of the HESES22 recreation), sum the values of HESCOL4. To find the estimated number of years of instance that were not completed (i.e. recorded in Column 3 of Table 6a of the HESES22 recreation), sum the values of HESCOL3. To find the estimated FTE, sum the values of HESCOL4A. The Column 3 and Column 4 totals may not be whole numbers, but the sum of these totals will equal the number of years of instance found by applying the filters above.

Table 6c: Part-time counts of years of instance and FTE for home feestudents on pre-registration health courses

38. For the population that appears in this table, the first filters to apply to the individualised file are:

HESHEALTHPOP = 1 HESMODE = PT.

- 39. To identify years of instance in the different columns, apply filters as set out in paragraphs 31 to 33.
- 40. Similar filters can be applied to those in paragraphs 34 and 35 to identify years of instance counted in a particular row.

Table 7: Home fee years of instance and full-time equivalence (FTE) on degree apprenticeships

- 41. For the population that appears in this table, the first filter to apply to the individualised file is HESAPPPOP = 1.
- 42. To further filter these years of instance, the following fields can be used:

HESMODE

HESLEVEL

HESREG

HESTYPE

PRGA, PRGB, PRGC11, PRGC12, PRGC2, PRGD.

43. For example, to filter to fundable part-time price group B years of instance that are in Column1, on another undergraduate course, then the filters to apply to the individualised file are as follows:

44. To find the total years of instance meeting these criteria, sum the values of PRGB. Of these years, the number estimated to have not been completed (i.e. recorded in Column 3 of the HESES22 recreation) is the sum of the values of HESCOL3_B, and the number estimated to have been completed (i.e. recorded in Column 4 of the HESES22 recreation) is the sum of the

values of HESCOL4_B. The Column 3 and Column 4 totals may not be whole numbers, but the sum of these totals will equal the sum of the values of PRGB. In summary, (sum of HESCOL3_Y) + (sum of HESCOL4_Y) = (sum of PRGY), where Y is the price group. The FTE of the years of instance found by applying the filters above (which is recorded in Column 4a of the HESES22 recreation) is the sum of the values of FTEB divided by 100.

45. To find the equivalent population of starters (i.e., students in Section B of this table), apply the above filters as well as HESAPPSTARTER = 1.

Funding tables

- 46. This section details how the 2023-24 funding allocations can be modelled using the 2022-23 ILR data, where HESES22 data has previously been used. To note, these tables will be made available in the week commencing 28 August 2023.
- 47. Within these tables the columns titled 'Calculations using HESES22 data' contain the figures shown in the latest 2023-24 grant tables. Some of these values may not match the grant tables if there have been any amendments to HESES22 data since the grant announcement or where mergers have taken place.
- 48. The columns titled 'Calculations modelled using 2022-23 Student data' contain values from the 2022-23 ILR data, and calculations that are based on this data.
- 49. The columns titled 'Difference' are the figures calculated using 2022-23 ILR data minus the figures calculated using HESES22 data.

Table A: Summary of 2023-24 allocations

50. This table is a summary of the teaching grant allocations shown in Tables B, C, D, E and F, and shows fixed allocations that are not based on HESES22 data. This table will be used to identify unusual differences at a high level; the tables on the five other sheets can then be used to look at the differences in more detail.

Table B: 2023-24 High-cost subject funding

- 51. This table shows the calculation of 2023-24 high-cost subject funding.
- 52. 'OfS-fundable FTEs' is the sum of Column 4(a) of the '1_Full_time' tab, Column 4(a) of the '2_Sandwich' tab multiplied by 0.5 and Column 4a(a) of the '3_Part_time' tab.
- 53. 'Adjustments for over-recruitment against medical and dental intake targets' is taken from column E.
- 54. 'Other FTE adjustments' is taken from column F.
- 55. 'Total FTEs for 2023-24 high-cost subject funding' is the sum of the FTEs in columns I to K.
- 56. 'High-cost subject funding (£)' is the 'Total FTEs for 2023-24 high-cost subject funding' multiplied by the rates of funding and scaling factor shown on the 'G_Parameters' tab.

Table C: 2023-24 Nursing, midwifery and allied health supplement

- 57. This table shows the calculation of the 2023-24 Nursing, midwifery and allied health supplement.
- 58. 'OfS-fundable FTEs (Full-time)' is taken from Column 4(a) of the '6a_Health_full_time' tab.
- 59. 'OfS-fundable FTEs (Part-time)' is taken from Column 4a(a) of the '6c_Health_part_time' tab.
- 60. 'FTE adjustment' is taken from column E.

- 61. 'Total FTEs for NMAH supplement' is the sum of the FTEs in columns H to J.
- 62. The 'Nursing, midwifery and allied health supplement (£)' column is the 'Total FTEs for NMAH supplement' multiplied by the rate of funding for that profession and level, as shown on the 'G_Parameters' tab.

Table D: 2023-24 Overseas study programmes

- 63. This table shows the calculation of the 2023-24 Overseas study programmes allocation.
- 64. 'Full-time years abroad (OfS-fundable)', 'Full-time years abroad (Non-fundable)', 'Sandwich year out years abroad (OfS-fundable)' and 'Sandwich year out years abroad (Non-fundable)' are the years countable for each mode and fundability status, taken from Columns 1 and 2 of the '4_Year_abroad' tab. Sandwich years out that are not taken under the Erasmus+ or Turing programmes are not included.
- 65. 'Total years countable for overseas study programmes' is the sum of the years countable in columns H to K.
- 66. 'Overseas study programmes (£)' is the 'Total years countable for overseas study programmes' multiplied by the rate of funding shown on the 'G_Parameters' tab.

Table E: 2023-24 Other high-cost targeted allocations

- 67. This table shows the calculation of other high-cost targeted allocations.
- 68. 'OfS-fundable FTEs' is the sum of Column 4(a) of the '1_Full_time' tab, Column 4(a) of the '2_Sandwich' tab multiplied by 0.5 and Column 4a(a) of the '3_Part_time' tab.
- 69. 'Adjustments for over-recruitment against medical and dental intake targets' is taken from column F.
- 70. 'Other FTE adjustments' is taken from column G.
- 71. 'Total FTEs for 2023-24 other high-cost targeted allocations' is the sum of the FTEs in columns L to N.
- 72. 'Postgraduate taught supplement (£)' is the 'Total FTEs for 2023-24 other high-cost targeted allocations' multiplied by the postgraduate taught supplement parameters shown on the 'G_Parameters' tab.
- 73. 'Intensive postgraduate provision (£)' is the 'Total FTEs for 2023-24 other high-cost targeted allocations' multiplied by the intensive postgraduate provision parameters shown on the 'G_Parameters' tab.
- 74. 'Accelerated full-time undergraduate provision (£)' is the 'Total FTEs for 2023-24 other highcost targeted allocations' multiplied by the accelerated full-time undergraduate provision parameters shown on the 'G_Parameters' tab.

Table F: 2023-24 Student access and success

- 75. This table shows the calculation of 2023-24 student access and success allocations.
- 76. **Premium to support successful student outcomes: full-time (main allocation and supplement).** The figure in the 'Total FTEs for 2023-24: Full-time and sandwich year out UG' row is the total FTE for full-time and sandwich year out UGs from the 'Total FTEs for 2023-24 other high-cost targeted allocations' column in 'E Other high cost targeted'.
- 77. **Premium to support successful student outcomes: part-time.** The figure in the 'Total FTEs for 2023-24: Part-time UG' row is the total FTE for part-time UGs from the 'Total FTEs for 2023-24 other high-cost targeted allocations' column in 'E Other high cost targeted'.
- 78. **Disabled students' premium.** The 'Total FTEs for 2023-24' figure is the total FTE for all modes and levels from the 'Total FTEs for 2023-24 other high-cost targeted allocations' column in 'E_Other_high_cost_targeted'.
- 79. **Premium for student transitions and mental health.** The 'Headcount of OfS-fundable undergraduate entrants' figure is the total OfS-fundable undergraduates included in 'Section B: New entrants' of the '5_Planning' tab.
